- (ii) Section 1 Chapter 2 of this scale supersedes Tradesmens Tool Kits listed in the AP830 Vol 3 Part A Sect 7.
- (iii) Section 1 Chapter 2 of this scale supersedes Basic Scales of Hand Tools listed in the AP830 Vol 3 Part A Sect 8.
- (iv) Section 2 Chapter 2 of this scale supersedes Basic Scales of Technical Equipment listed in the AP830 Vol 3 Part A Sect 8.
- (v) Section 2 Chapters 1 and 2 do not include Vocab Section 22 and 23 (Clothing and Accoutrements) which is listed in AP830 Vol 3 Part C.
- (vi) Section 2 Chapters 1 and 2 Col 24/18 (Crash and Salvage); Col 17 (Battery Charging); scale only special-to-type equipment required to support the CANBERRA aircraft. Basic scale of entitlement are listed in AP830 Vol 3 Part A Sect 8.

(8) FLY-AWAY PACKS (FAP) - SECTION 3

Fly-away packs are generally made up from 'in-use' GSE, mainly drawn from 1st Line resources at the Aircrafts Home Unit and is therefore NOT an additional entitlement. SECTION 3 IS NOT A PROVISIONING DOCUMENT.

(9) SUBMISSION OF DEMANDS

DEMANDS ARE TO BE RESTRICTED TO THE MINIMUM CONSISTENT WITH EFFICIENT SERVICING. The requirements of units vary and discretion is to be used when demanding on the basis of this scale which is to be regarded as the maximum entitlement.

(10) AMENDMENT TO SCALE

Holders of this scale are to ensure that amendments are incorporated without delay. The amendment certificate at the front of this publication is to be completed accordingly. Suggestions for amendments to these scales should be forwarded by Command Headquarters or other equivalent formations, together with comments to:
