

PREFACE

- 1 This publication contains Topic 1 and 2 information on the NBC intercom. unit. Topic 3 is issued separately. Because the intercom. unit is a simple, low-cost device, servicing is restricted to second line and there is no requirement for a Topic 4, 5 or 6. The bay servicing schedules normally contained in Topic 4 have been included in the present Topic 1.
- ▶ 2 The initial issue of Topic 1 described the NBC intercom. unit as originally introduced into service. Subsequently, a number of minor production changes were made by the manufacturer and Topic 1 has been amended to reflect these changes. Details of the variations between early and current units are given in Topic 2, GO leaflet No. 1.
 - 3 The subject matter of this publication may be affected by Defence Council Instructions or Special Technical Instructions. When this occurs, an amendment will normally be issued as soon as possible, but if discrepancies appear, the instruction is to be taken as the overriding authority.
 - Each page published with the initial issue bears the date of issue. Subsequent new or replacement leaves will be issued under the cover of an amendment instruction sheet, and will bear the number and date of that amendment. On all replacement pages, changes of technical import will be enclosed by indicator triangles, thus ▶....., positioned outside the type area. When the content of a chapter, or of a table within a chapter, has been so changed as to make the use of indicator triangles impracticable, the amended chapter, or table, will carry the note "(Completely revised)" beneath the title.
